'REFER A FRIEND' CAMPAIGN at Olivine by Mirvac - TERMS AND CONDITIONS

The following terms and conditions apply to the "Refer-A-Friend" Campaign at Olivine by Mirvac (**Promotion**) which will take place from 1pm on Wednesday 7th November 2018 until 11:59pm on Monday 31 December 2018 (**Promotion Period**).

Definitions

- 1. In this Promotion, unless the context is otherwise provided, the following words are defined as follows:
 - a. **Contract** means a contract of sale validly entered into by a Customer or the Referrer (as the context requires) for the purchase of one or more lots at Olivine by Mirvac from the Promoter.
 - c. Customer means a natural person over the age of 18 years who:

Promotion

Promotion

- The Referrer acknowledges and agrees that the Promoter shall not be liable to the Referrer for:
 - a. late, lost, misdirected, incomplete or incorrect Referral Forms;
 - b. any financial or legal implications (or otherwise) that may arise from the Promotion; or
 - c. replacing any lost, stolen or damaged Pre-Paid Gift Card.
- 10. Independent financial, legal or other professional advice should be sought by each Referrer.
- 11. The Promoter reserves the right, at its sole discretion, to cancel, terminate, modify or suspend the Promotion if:
 - a. for any reason the Promoter's circumstances change; or
 - b. the Promotion is not available, the Promoter reserves the right but not the obligation to substitute the Promotion for another similar item, of equal value.
- 12. The Promoter reserves the right to take appropriate legal action against the Referrer if the Referrer breaches the terms and conditions of this Promotion
- 13. To the extent permitted by law, under no circumstances will the Promoter be liable to the Referrer for any direct, indirect, consequential, exemplary, incidental, special or punitive damages arising out of or in connection with the Referrer's participation in this Promotion, even if the Promoter has been advised of the possibility of such damages.
